CEMENT IN NOVEMBER 2018

This report provides monthly data on the shipments of cement to final customers and the production of clinker in the United States from January 2017 through November 2018.¹ Data on the imports of cement and clinker for November 2018 also are provided. Listings of leading States (below) are in order of descending activity.

Total shipments of portland and blended cement in the United States and Puerto Rico in November 2018 were 7.78 million metric tons (Mt), a decrease of 5.3% from shipments in November 2017 (tables 2A and 2B). Shipments for the year through November totaled about 91.5 Mt, an increase of 2.6% from those for the same period in 2017. The leading producing States for portland and blended cement in November 2018 were, in descending order, Texas, California, Missouri, Florida and Alabama. (table 1A). The leading cement-consuming States (Texas, California, Florida, Ohio and Illinois) received 41% of the November shipments (tables 2A and 2B).

Masonry cement shipments were 172,000 metric tons in November 2018, a decrease of 12.5% from those in November 2017 (table 2C). For the year through November, shipments totaled 2.26 Mt, essentially unchanged from the same period in 2017. The leading masonry-cement-consuming States in November 2018 were Florida, Texas, California, North Carolina and Tennessee; these States received about 58% of the November shipments (table 2C).

Clinker production totaled 6.4 Mt in November 2018, a decrease of 5.4% from the output (excluding Puerto Rico) in

November 2017 (table 4). For the year through November 2018, production was 70.4 Mt, essentially unchanged from the same period in 2017. The leading clinker-producing States in November 2018 were Texas, California, Missouri, Florida, and Alabama.

Tables 5, 6, and 7 list import data from the U.S. Census Bureau; however, data for clinker imports into the Seattle, WA, and the Detroit, MI, customs districts do not include material trucked in from Canada on an informal entry basis. Likewise, imports of cement into the El Paso, TX, district may be missing significant informal entries from Mexico. Monthly imports can show significant year-over-year changes for a variety of reasons and commonly do not correlate well with consumption levels in the respective import districts in the same month. November 2018 imports of cement and clinker totaled 1.1 Mt, a decrease of 7.9% from imports in November 2017. Imports for January through November 2018 totaled 13.9 Mt, an increase of 9.9% from imports in the same period in 2017.
